Greetings from our President

Dear friends of CRSM,

This past year, Cristo Rey St. Martin College Prep celebrated 20 years of educating young people in Waukegan and North Chicago!

According to the U.S. Bureau of Labor Statistics, over 50% of small businesses fail in their first 5 years. In fact, only 1/3 persist after 10 years. Clearly, CRSM beat those odds and continues its important mission.

Our students are flourishing despite stark statistics for other young people from low-income backgrounds:

- High school drop-out rates at local public schools here remain close to 50% but at CRSM, over 91% of the students who start with us in 9th grade go on to graduate from CRSM. For the Class of 2025, it was a whopping 98%!
- Less than 15% of high school graduates in Waukegan and North Chicago enroll in college. In contrast, 100% of CRSM seniors were accepted to at least one bachelor's program for the last 6 years in-a-row, with 91% directly enrolling into a bachelor's program.
- CRSM Alumni graduate college at 3.5 X the rate for students from the lowest quartile of family income nationally. In fact, CRSM students are now graduating from Bachelor's programs at the same rate as young people from the highest quartile of income.
- CRSM represents only 7% of the high school population in North Chicago and Waukegan, yet more than 50% of all new bachelor's degrees being earned in our area by Pell-eligible students belong to CRSM alumni.

Our success has always been a team effort – a collective success resulting from the hard work of our students and teachers AND the generosity of so many people, including you! We can't do it alone. **Your support is more important than ever!**

Twenty years is an important milestone, but our dreams are greater than that. We hope that CRSM will flourish for decades and decades to come.

Your generosity makes it possible for our students to continue to develop their God-given talents and make a difference in our world - helping them reimagine a better future for themselves and all of us.

Thank you so much for being such an important part of our first 20 years and, more importantly, continuing the journey with us into our next!

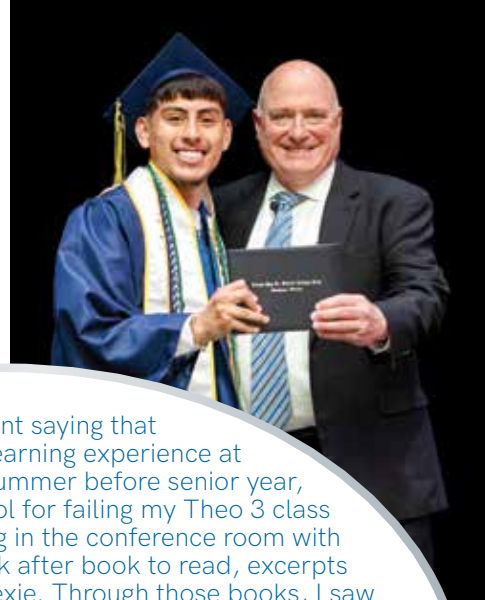

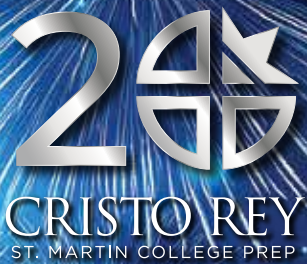

Celebrating 20 Years of Partnership

For the past 20 years, Cristo Rey St. Martin and the Lake County State's Attorney's Office have shared a meaningful partnership that has provided over 100 students with hands-on experience in the legal field. Through this internship program, students gain exposure to real-world legal work—participating in court observations, assisting with data entry and filing, and even contributing to projects like DEI newsletters. Treated as valued members of the team, students are assigned tasks based on their strengths and interests and are given the opportunity to work alongside attorneys, judges, and law enforcement professionals. The partnership has inspired many CRSM students to pursue careers in law, with several returning as full-time employees in the office.

One of the driving forces behind the program's success is Pajet Rollins, who has overseen the partnership from the beginning. A lifelong

mentor and community advocate, Rollins was chosen to supervise the program because of her deep roots in the area and her natural ability to connect with young people. *"From day one, I've been committed and invested,"* she shared. *"You cannot put a price tag on that. It's bigger than money. It's what the community is supposed to be doing—empowering and mentoring young people."* Her dedication reflects the spirit of the partnership itself: building lasting relationships and creating pathways for students to grow, lead, and give back.

Mosaics in Chapel



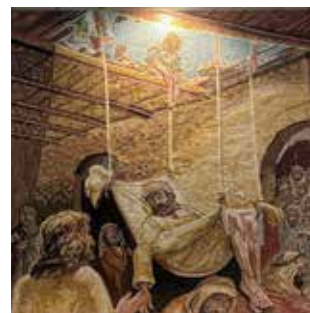

Know Your Rights



This past winter, Cristo Rey St. Martin partnered with Mano a Mano Family Resource Center to host six "Know Your Rights" presentations for CRSM families and the larger Lake County community. Mano a Mano is a non-profit CWSP partner that offers a variety of services and resources including health care, educational classes and workshops, and immigration legal services, focusing especially on the hardest to reach and most vulnerable families and individuals in the community. Numerous presenters from Mano a Mano came in, including CRSM alumni who now work for Mano a Mano, to provide information to community members interested in learning more about basic constitutional rights guaranteed to all residents, regardless of immigration status. Presentations were also shared with all CRSM students in Theology classes during the month of February.

Students Experience Owakonze Canadian Wilderness Camping



Last summer, eight Cristo Rey St. Martin students took part in a transformative weeklong journey with the Center for Conservation Leadership (CCL) at Lake Forest Open Lands, venturing deep

into the Canadian wilderness. At Owakonze—a remote camp on Baril Lake, Ontario, and a site for Urban Wilderness, which also partners with CRSM on an annual boat build—students traded modern comforts for tents, open-fire cooking, and star-filled skies. They learned canoeing, outdoor cooking, and survival skills before paddling to a secluded island, where they camped under a full moon and built lasting connections with nature and each other.

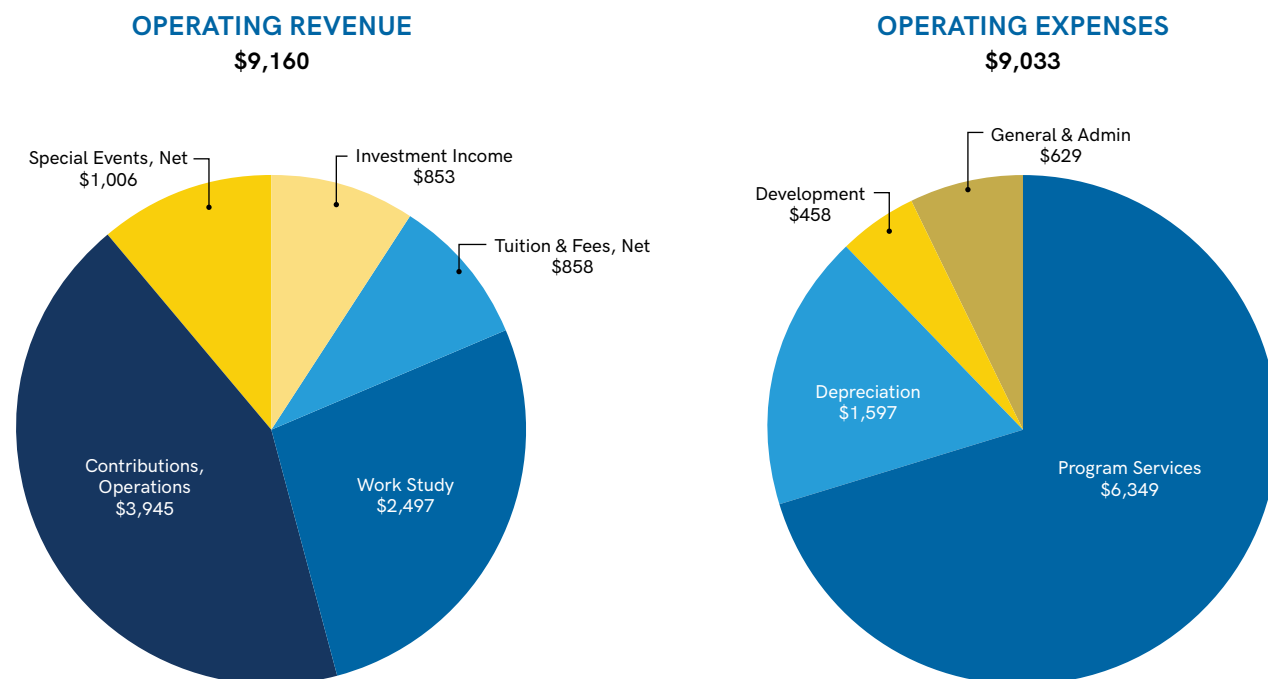

CRSM Goes Solar

We at CRSM have taken a major step toward sustainability with the launch of our rooftop solar array, now generating clean, renewable energy for the school. Fully activated on September 20, 2024, the system is already making a measurable impact, producing 44,592 kWh in October alone and covering nearly 39% of our energy use that month. While winter months brought lower production due to shorter, cloudier days, the system still delivered strong output, with more than 19,000 kWh generated in both November and January. On an annual basis, the

solar array is projected to meet about 44% of our total electricity needs. This transition to solar power reflects our ongoing commitment to reducing our carbon footprint and embracing more sustainable operations. Electricity from the panels is used directly on-site, lowering our reliance on the traditional energy grid and cutting utility costs. Early performance data has been consistent with expectations, confirming the long-term value of this investment. With brighter, sunnier months ahead, we're excited to see the system reach peak production and further our mission to go green.
